4. Nanotechnology research discussion.

After further discussion, the committee agreed to move forward, and Amy Treonis, Mike Maceyka, and Mike Miller will draft recommendations to review at the next meeting.

5. IBC Charter.

The chair shared that once the committee drafts recommendations for nanotechnology, the committee will review the IBC charter to incorporate what the committee has been doing over the past year. The chair will attempt a first revision to discuss at the next or December's meeting.
